

2024 registration continues. Late registration began January 2 for returning referees, and dozens of entry-level clinics are currently offered to train new referees. Thus far, there are about 3,100 licensed referees.

# Assignr

As mentioned last month, the North Texas Soccer Referee Program successfully switched assigning platforms from GameOfficials to Assignr during the Tournament of Champions. Many associations have joined the assigning platform as well since last month's report. There will be an assignor Zoom meeting Wednesday that will help assignors with questions they may have using the platform. In fact, excitement has been mounting about this training because a special guest trainer will be attending—the honorable, award-winning Rob Martella!

Our development groups continue to provide training and support for their respective groups.

#### Elite

The Elite group provided in-person training Monday, February 5 at the state office to our Regionals, soon-to-be Regionals, and National Referees—along with coaches.

#### **Jam Sessions**

We opened up Jam Sessions last month to all Referees. The January 18 training was hosted by Travis Haight—a Regional Referee and Mentor who has agreed to take over this training each month. He provided information about professionalism and game-day expectations and fielded questions from the participants. Many of the questions surrounded the topic of dealing with sideline behavior.

#### **Junior Elite**

One of our National Assistant Referees, Jason Guillen organizes our Junior Elite program each month and has a team of Regional and National Referees/Assistant Referees, and Regional and National Coaches helping him. This group provides training to Referees seeking to advance and Advanced Referees will meet again Thursday, February 15.

#### Female Officials' Recruitment, Coaching, and Empowerment

The FORCE group is rolling strong. Started with help of the US Soccer Innovate to Grow grant by and for female referees to provide training and support to development, the group provides small-group mentoring for female referees age 15 and older. Their recent topic was on Warning, Caution, and Send-Off with regards to coaches, substitutes, and team officials along with dealing with sideline behavior.

## WhistleMania<sup>TM</sup> 2

Also with assistance from the US Soccer Innovate to Grow grant, the North Texas Soccer Referee Program will be hosting WhistleMania<sup>TM</sup> 2 Saturday, July 20, 2024, in Frisco. The goal is to have over 600 referees and 30 assignors attend this year's event.

Four members of the North Texas Soccer Referee Program traveled to the United Soccer Coaches Convention in Anaheim last month. Along with Referee Chairman Trent McColly, State Director of Assessment Bret Harp, Referee Coach Jarrod Tackel, and Regional Referee Josue Meneses who helps with the Junior Elite Referee Program training and is a soon-to-be Mentor.

We held our final fitness testing for recertifying Regional and Advanced Referees January 20. Special thanks to the impressive, honorable, award-winning Rob Martella for coming out to help with make this test a success for our referees in the freezing cold.
