# REGION III INTERSTATE PERMISSION / TRANSFER / GUEST PLAY FAQ's

\*This form is for USYS registered players and teams only\*

This form must be completed by any player requesting permission to play with a team registered with a State Association other than the State Association in which the player resides and by any player who moves from one State Association to another during the Seasonal Year. It is the responsibility of the player and/or guardian to submit the form to the appropriate parties within both the home and accepting State Associations.

USYSA Rule 201 requires that a youth player register each seasonal year in the State Association in which he/she resides with his/her parent(s)/guardian(s). A youth player wishing to participate with a team from a State Association other than the state in which they reside must receive written permission from both State Associations prior to participation.

#### Instructions:

- 1. Player must register and pay any appropriate fee(s) of the State Association in which he resides
- 2. Complete the Player Information and Type of Change sections of this form
- 3. Submit completed Interstate Permission form to the State Association in which the player is registered
- 4. Releasing State Association must complete the Releasing section of this form
- 5. Accepting State Association must complete the Accepting section of this form

### **Interstate Transfer:**

This option is for a player that resides in one State, but wishes to be fully released from that State in order to play with a team from another State Association. This option will remove the player completely from their current State registration and team. They are not allowed to be dual registered with two States.

#### **Relocation Transfer:**

Player has moved from one State to another State within a seasonal year and wishes to be fully released from their previous State to play in the new State in which they reside.

#### **Guest Play Permission:**

Player that is registered with their State and wishes to guest play only in a tournament with another State's team.

#### **NTSSA Specific Notes:**

- Form must be completed with all signatures before NTSSA will sign.
- Releasing State must sign first if player is not from NTSSA.
- There are no guest players for academy under NTSSA. If a player from outside of NTSSA wants to play on a NTSSA academy team, they would have to do an interstate transfer and fully release from their current State and team in order to fully register with NTSSA to play with an NTSSA academy team in any event.
- It is the team's responsibility to ensure they know the guest player rules for the event they are
  participating with and completing any form for.
- NTSSA recreational players may have their rec home association sign as the Coach of Current team if needed.
- There are no guest players allowed in State Cup.
