Activities since the last board meeting:



The North Texas Soccer Referee Program continues its mission of recruiting, training, developing, supporting, and retaining referees. 2024 registration continues. Since the last report, almost 1,160 referees have registered or recertified. We have not reached our goal yet with 4,260 referees licensed for 2024 currently.

The North Texas Soccer Referee Committee congratulates six referees from North Texas for being assigned to matches during the first few of MLS. While the North Texas Soccer Referee Program supports ALL referees, the State Referee Committee congratulates several of our officials for being assigned to their first MLS games. Lorenzo Hernandez has worked as referee. Fevzi Demirhan, Chana Forstall, and Seun Yinka-Kehinde have been assistant referees. Emmy Nonso-Anyakwo and Jorge Luna Hernandez have served as fourth officials.

Three members of the State Referee Committee attended the US Soccer SRC Workshop in Chicago the last weekend in February. US Soccer introduced new evaluation standards for Regional Referees—the second version in two years. There was great discussion around referee abuse with breakout sessions to share ideas about curbing misconduct towards officials.

The Referee Committee continues to prepare for upcoming events: State Presidents Cup March 8-10, State Cup May 1-12, USASA Regionals in South Carolina June 7-9, Regional Presidents Cup in Plano June 14-18, and Southern Regionals in Tampa and Auburndale June 21-27. We have been asked to send 12 referees and three coaches to Regional Presidents Cup and 19 referees, 5 referee coaches, and a HOD to Southern Regionals.

WhistleManiaTM 2

With assistance from the US Soccer Innovate to Grow grant, the North Texas Soccer Referee Program will be hosting WhistleManiaTM 2 Saturday, July 20, 2024, at Warre Park in Frisco. The goal is to have over 600 referees and 30 assignors attend this year's event.
