- Re-evaluate the program for 18 & 19-year-old players
- Adult-only Associations board members are required to take Safe Sport when they have no youth players

Janet stated she heard back from the CEO who answered her and suggested she speak with Safe Sport Compliance. Janet reported she had a good conversation with the person in Safe Sport Compliance and she will be looking into ways to improve the areas of concern.

Janet Campbell stated she, Jerry Deaton, and Rachene Badii will be attending the USASA meeting in Denver this month.

Janet Campbell asked for a GotSport update. Jim Mills noted they have not fixed the text messaging capabilities. Trent McColly stated he was at a member association that is having an issue with GotSport. Trent said he directed them to contact Brittany Campbell or Lisa Skiles.

David Osborne noted an '09 ODP Player, Brooklyn (Mighty) Moran, was killed in a car crash.

## STAFF DISCUSSION

Gary Williamson noted ODP Tryouts have been completed with 958 players trying out. They will start their fall training sessions in October.

Jim Wagner presented Partnership Marketing Approval from Mojo, an online coaching app. After much discussion, a motion was made and seconded to have the contract reviewed by David Messersmith and to move forward once David has reviewed it and any changes have been made based on his recommendation. The motion was approved.

David Osborne submitted another name to be a part of the ODP Committee. The addition was approved.

Carlos Quinones stated he is planning to hold a Zoom A&D Workshop.

Jerry Deaton noted the adults have been losing some of their top teams. He stated he has been working with Arlington, Fort Worth Adult, Plano International, and NTPSA to cross-play for some league games. This will be starting this weekend as a test program.

# David Messersmith Executive Director September 13, 2022

Finalized negotiations on insurance renewals for General Liability, Excess Liability, and Youth Player Accident Medical. After several months of negotiations with two different brokers, we were able to renew the policies starting 9-1-22, originally proposed as a 2% increase, for the final amount of a 4% decrease, which equaled a \$20,205 savings. That savings should carry forward to each of the next 3-4 future years as well, as our starting point is lower.

Finalized negotiations on the office lease renewal. Again, after several months of negotiation, and two different representatives with the landlord, we were able to do a 5-year renewal beginning 9-1-23, which was reduced by \$100,135 from their original proposal. That includes 3 months of free rent in this fiscal year, and a reduction of \$13,850 each of years 1-5 of the new lease, from where we started.

# **Board Report July/August**

# Jim Wagner Chairman, Coach Education

July kicked off with the AGM and meeting with many officers and directors from around the state. David Osborne and I ran an ODP/Coach Education combined workshop that was well attended. When the room was asked who is a currently a coach, nearly 100% of Presidents and Officers in the room raised their hands. We reviewed the current situation within the state and future on improvements, including bringing back the coaching convention aspect to the AGM next year, which was well received with clapping and nods of approval.

Continued the discussions with MOJO Sports that began in January at the USYS Workshop and United Soccer Coaches Convention. Going into August, which is a member associations critical period, I introduced MOJO to several associations with extremely positive feedback, especially in aiding in the recruitment of coaches. I believe this app will be the solution to associations disbanding teams and issuing refunds due to lack of coaches available. This could improve overall state member enrollment from 2-5% and aiding in retainment could be another impact as well.

MOJO and USYS rolled out the 10 week Play-Practice-Play curriculum for the U6, U8, U10, U12 and U14 age groups in mid-August, Gary and I reviewed them and after some additional Q & A with Tom Condone of USYS determined that they were well done. This prompted a meeting with Janet Campbell, David Messersmith and me with Tom Arnett, Chief Customer Officer of MOJO to discuss a partnership with MOJO Sport and NTSSA. I had already discussed some expectations of sponsorship for the coaching program and Janet also successfully secured the promise of sponsorship in the form of presence and booth sponsorship at our AGM. That partnership will be discussed at the September NTSSA board meeting.

At the AGM, I also introduced the Coaching Educator pilot program I have gotten the okay for from Zac Crawford of the Federation for North Texas. We now have 6 candidates of up to 24 educational "pods" we intend to set up throughout the NTSSA area. Those interested in obtaining those educator licenses include the associations of:

Arlington Soccer Association
Garland Soccer Association
Greater Lewisville Area Soccer Association
Greater Wichita Falls Soccer Association
Irving Soccer Association
Midland Soccer Association

That CE Course closes in December and begins in January. That Coaching Educator License will replace the or Grassroots Instructor License (GRIL) of the past 5 years.



In August, USSF held a Health and Safety Summit in part of the Recognize to Recover Program. It was made available nationwide for all state staff, clubs, teams, coaches' players etc. Knowing our constituent Presidents and DoC's are constantly asked about many of the topics being covered, I modified six pieces of marking collateral to make it easy for them to get out via GotSport blasts to their memberships and or social media outlets and provided to each association President.

This was done so our associations know that we have their best interests in mind and know they want ready to use/send materials to go out to their members.

For the two dozen or more parents and coaches at LCSA that attended, they had only positive things to say about the topics cover, though most agreed it perhaps should have been broken down into shorter, more digestible bites of 2 or 3 different calls.

Although the August meeting was pushed back and I could not attend that evening because of prior commitments, I was able to meet with Lisa Skiles and Gary Williamson in the office regarding the Coaching section of the website. We went over obsolete information that I pointed out as well as some Janet had found in a different area of the site.

The goal was to update the site into more of a user-friendly tool for coaches to discover information on learning offered as well as information on coaching and other resources. We decided the first stage was to eliminate the obsolete and reorganize and categorize the information. The first phase was to consolidate and mimic the look of the Georgia state site. The second phase would be next year and mimic more powerhouse Massachusetts set up. This will give our association members and their coaches access to the tools necessary to afford the betterment of the game.
